Sub:- Amendment in affiliation Bye-laws Rule 3.3(i) chapter II-reg.

Sir/Madam,

Consequent upon recommendations of the Affiliation Committee made in its meeting held on 24.06.2013 and subsequently approval of the Governing Body of the Board in its meeting held on 28.06.2013, the following amendment in affiliation Bye-laws of the Board has been made by the Board:

Existing Rule 3.3 (i) chapter II

The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T. Govt. Its application either should be forwarded by the State Govt. or there should be a No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with the CBSE. "No Objection Certificate" once issued to any school will be considered at par even if it prescribes a specific period of *stage unless it is withdrawn. Condition of submitting a No Objection Certificate will not be applicable to categories 3.1(i) to (iv)

Amended Rule 3.3 (i) chapter II

The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T Govt. and also to produce evidence to this effect that the applicant school had intimated to the concerned Education Department of the State about the application made to CBSE for seeking affiliation with the Board. In case, the Board receives any objection during the process of application of the school, the Board may ask the concerned school to produce the No Objection Certificate from the State Government or otherwise it would be assumed that concerned State/U.T. Government has No objection.

The above amendment is brought to the notice of all concerned.

3.3(i) CHAPTER II-Reg**

Consequent upon the recommendations of Affiliation Committee made in its meeting held on 20.06.2017 and subsequently approved by the Governing Body in its meeting held on 29.06.2017, the following amendment/additions in Affiliation Byelaws as Rule No.3.3 (i)a has been made.

Existing Rule 3.3(i) Chapter-II	Amendment/ Addition in Rule 3.3(i) Chapter II
<p>The school seeking provisional affiliation with the Board shall submit the following documents</p> <p>(a) Formal prior Recognition letter from concerned State Education Department i.e. Recognition for classes I to V required for Middle Class Approval and Recognition for classes I to VIII required for Provisional Affiliation upto Secondary Level</p> <p style="text-align: center;">AND</p> <p>(b) No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with CBSE No Objection Certificate once issued to any school will be considered at par even if it prescribed a specific period and /or level unless it is withdrawn. Condition to submit No Objection Certificate will not be applicable to categories of schools stated at Rule 3.1 (j) to (iv) of Affiliation Bye- laws of the Board.</p>	<p>Rule 3.3(i) - The school seeking provisional affiliation with the Board shall submit the following documents</p> <p>(a) Formal prior Recognition letter from concerned State Education Department i.e. Recognition for classes I to V required for Middle Class Approval and Recognition for classes I to VIII required for Provisional Affiliation upto Secondary Level</p> <p style="text-align: center;">AND</p> <p>(b) No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with CBSE No Objection Certificate once issued to any school will be considered at par even if it prescribed a specific period and /or level unless it is withdrawn. Condition to submit No Objection Certificate will not be applicable to categories of schools stated at Rule 3.1 (i) to (iv) of Affiliation Bye- laws of the Board.</p> <p>Rule 3.3(i) (a) - The schools in foreign countries seeking affiliation with CBSE, shall submit NOC from the Embassy of India/High Commission of India located in that country along with the permission to run the school from the Education Department of that Country stating that the school fulfills the prescribed norms of that country. The schools in foreign countries shall also possess the minimum area of land as specified by the Government of that country. The ownership of land/building/premises shall also be in favour of school/society/trust/company running the school or leased in favour of school/society/trust/company running the school in accordance with the prevalent government norms of the respective country.</p>
